

# **REZONING AMENDMENT APPLICATION**

## **PROPOSAL:**

"City of Prince George Zoning Bylaw No. 7850, 2007, Amendment Bylaw No. 9317, 2022"

The purpose of this application is to amend "City of Prince George Zoning Bylaw No. 7850, 2007" by rezoning the subject property from C7: Transitional Commercial to RM6: Mid-rise Residential to facilitate the construction of an "apartment hotel" development offering dwellings for rent for periods of no less than thirty (30) days.

The applicant has agreed to register a Section 219 Covenant on title of the subject property to restrict the maximum density to no more than seventy (70) dwelling units per hectare which will permit a maximum of forty-three (43) dwelling units on the subject property and limit the maximum height of the principal development to 12.0 metres.

This notice is provided in advance of first and second reading of the proposed bylaw. In accordance with Section 464(2) of the Local Government Act, as the proposed bylaw is consistent with the City's Official Community Plan, a public hearing will not be held.
