The City of Prince George kicked off the OCP Review in fall 2023. The City's existing OCP was adopted in 2011 and a lot has changed since that time.

#### BACKGROUND

The OCP Review has generated a lot of good discussion about our social health and wellbeing. At public engagement events, people share personal struggles and success stories with friends, neighbours and municipal planning staff. These stories are important to the OCP Review process because they inform decisions about how best to manage land, growth and development in ways that improve the social health and wellbeing of all PG residents.

## **WHAT WE HEARD**


During the first round of engagement, we heard you say:
